I have images in the Resources folder of the assembly and I am importing them using Image as in the code below. I am getting the following exception when the app runs on the emulator. NOTES [1] "Under the Alabama Distilling Act, Code 1940, Tit. 14, §§ 1-4, a license must be obtained before distillation of liquor. No such license is provided for the sale of other articles, and therefore the act does not prohibit sale of liquor by the drink, but simply seeks to prevent the carrying on of the business of a distiller without the legal authority of the State. The sale of liquor by the drink is not forbidden by the law, but the manner in which the business is carried on must be regular and conform to the provisions of the law.
